Privacy Policy

Samrat Pharmachem Limited (“SPL”) pledges to comply with internationally recognized standards of privacy protection, including General Data Protection Regulation (“GDPR”). We, at Samrat Pharmachem endeavour to ensure and maintain the privacy and security of all personal information. This Privacy Policy provides specific information about the processing of your personal data required by the GDPR (to the extent it applies to you). We urge you to carefully read this Privacy Policy before accessing or using Samrat Pharmachem Limited website (“Website”). If you proceed to access or use this website, you are agreeing to abide by this Privacy Policy, without any exceptions. You may not access or use this Website if you do not agree to this Privacy Policy.

INTENDED USE OF PERSONAL DATA

Most of the sections of our Website do not require any form of registration and/or creation of account. However, if some sections of our Website require registration, such registration shall be at your discretion and you may choose to not to register with us, however in such event you will not be able to access such section. In the event you choose to register, you may need to fill in certain fields to gain full access to such section of the site by choosing a user name and password and/or for us to respond to your query.

SPL may collect and use personal data to provide information to you about us, to market products and services, to process your orders or applications submitted by you through the samratpharmachem.com/careers, or to communicate with you when you join our Talent Community, to create products or services to meet your needs, to seek your feedback or to contact you in relation to those services offered on our Websites, to provide you educative information to help resolve your problem and/or to help build your knowledge as also to allow you to subscribe to our newsletters.

SPL’s legal basis for collecting and using your personal information will depend on the nature and circumstances on the processing. To the extent the processing of your personal data by Samrat Pharmachem falls under the provisions of the GDPR, the processing of your personal data is based either on:

- **A legitimate interest** (Art. 6 (1) (f) GDPR) in creating, developing and improving our Website and services, recruitment process and activities, in communicating with you, in responding to your requests, resolving your problems with our Website or services, in seeking feedback, as well as protecting our legitimate business interests and legal rights, including in connection with legal claims
- **Your consent** (Art. 6 (1) (a) GDPR) for carrying out direct marketing and providing the newsletter, as well as information about upcoming events and job opportunities when you join our Talent Community

- **The necessity to perform the contract with you and taking steps prior to entering into the contract at your request** (Art. 6 (1) (b) GDPR) for processing your order, to make informed decisions on recruitment and assess your suitability for the role, to communicate with you about your application, to respond to your inquiries and schedule interviews;
- **The necessity to perform a legal obligation** (Art. 6 (1) (c) GDPR), when we are required to do so by law, e.g., by virtue of our obligation to keep books or where obliged to respond to a legal enforcement request, warrant, search order or subpoena.
- Unless required by law, providing personal data is voluntary; however, a failure to provide it may prevent you from taking part in the recruitment, conclude an agreement with us or receive marketing communications.

Your personal data is stored for as long as it is necessary to achieve the specific purposes for which the data was collected:

- When we process your personal data for the purposes of direct marketing, including information provided to you when you subscribe to our Talent Community, we will store the data until you withdraw your consent or object to such processing.
- When we process the data collected as a part of communications with you or/and during customer service, we will keep the data for the period necessary to respond to the inquiry, complaint or request.
- When we process the data to perform the contract with you, we will keep the data for the period necessary to perform our obligations under the contract and, if applicable, for the period specified in relevant provisions of law.
- When you apply for a specific position, we will keep your data for the period necessary to carry out the recruitment process or repeat the process where needed, but not longer than three months from the end of the recruitment process.
- When we process the data to comply with our legal obligations and enforcement requests, we will keep your personal data for a period specified in applicable laws.
- When we process the data based on our legitimate interest we will keep your personal data until you object to the processing of your data for these purposes, and we consider such objection effective or for the period specified for particular processing operation we perform.

SPL is not obliged to store your data for a period which is beyond the intended purpose for which such data was collected or submitted, after considering any applicable regulatory requirements and shall be governed by the data disposal policy followed at SPL.

This website is not intended nor aimed for the use or access by children below 18 years of age. SPL does not knowingly collect, use or disclose personal data from a minor under the age of 18. We are not processing your personal data by implementing automated decision-making and we do not perform profiling operations on your personal data.

NON-DISCLOSURE OF INFORMATION

Samrat Pharmachem Limited will not sell, share, or otherwise distribute your personal data to third parties without implementing appropriate safeguards, and if required to provide the same to a third party, for further processing or connection to its business, it will in accordance with applicable law for the purpose for which the data were originally collected.

SPL will, wherever possible, endeavour to ensure that the disclosure and intended use of the data are clearly indicated and that such third parties provide the same level of protection as SPL.

SPL may also share your personal data with third party entities placing their cookie files or plug-ins on our Website, allowing them to collect specific information about your use of the Website and services (more information available in our [Cookie Policy](#)).

Our Website may also display content from a third-party website or service (e.g. social media plug-ins). We may process statistical data about your activity on our social media profiles. YOUR RIGHTS

If Samrat Pharmachem Limited has collected your personal data, you have the right to update your personal data. You have also the right to request access or erasure of your personal data, restriction of processing, and the right to object to the processing of your data, as well as the right to ask us to pass data that you provided to us (for the processing of which you consented, or which you provided in order to conclude an agreement) to another
